



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Awarding Bid for SWAT Tactical Vests for Sheriff's Department

WHEREAS, it is the intent of the Will County's Sheriff's SWAT Department to be equipped and ready for dangerous situations, and

WHEREAS, in order to obtain the most competitive pricing for SWAT tactical vests, proposals were solicited, and

WHEREAS, on May 24, 2019, the County Executive's Office opened two (2) proposals for the purchase of tactical vests, and

WHEREAS, after review, the Sheriff's SWAT Department has recommended to award to the lowest responsible bidder of Streicher's Police Supply, Minneapolis, MN, for the unit price of \$2,830.00, for the purchase of thirty-five (35) units, for a total extended price of \$99,050.00, and

WHEREAS, the second bid, from Ray O'Herron, Danville, IL, was disqualified due to incorrect Bid Bond amount, and

WHEREAS, the Judicial Committee has concurred with this recommendation, with necessary funding available in the Sheriff's Budget.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract to provide tactical vests for the Sheriff's SWAT Department to the lowest responsible bidder of Streicher's Police Supply, Minneapolis, MN, for the unit price of \$2,830.00, for the purchase of thirty-five (35) units, for a total extended price of \$99,050.00.

BE IT FURTHER RESOLVED, that the Preamble of this Resolution is hereby adopted as if fully set forth herein. This Resolution shall be in full force and effect upon its passage and approval as provided by law.
