WHEREAS, after reviewing such proposals, the recommendation from the Director of Facilities is to award the bid to the lowest responsible bidder, Filloto Construction, Inc., Crest Hill, IL for a total cost of \$73,150.00 for Salt Dome Roof Repairs at the D.O.T. Joliet and Monee locations, pursuant to the terms and specifications of the attached Bid Tab Sheet, and

WHEREAS, the Executive Committee concurs with this request.


NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract for Salt Dome Roof Repairs at the D.O.T. (Department of Transportation) Joliet and Monee locations to the lowest responsible bidder, Filloto Construction, Inc., Crest Hill, IL for a total cost of \$73,150.00 pursuant to the terms and specifications of the attached Bid Tab Sheet.



Four (4) bids were received with the lowest bid of \$73,150.00 being received from:

One (1) of the four (4) bidders submitted pricing for a non-solicited alternate roofing system which was deemed non-responsive to the invitation for Bids and therefore not considered by the County.
