**Awarding Bid for Food Service at River Valley Juvenile Center**

WHEREAS, in order to receive the most competitive price available, the Will County Executive's Office solicited bids for food service for River Valley Juvenile Center, and

WHEREAS, after reviewing such proposals, the River Valley Juvenile Center Director, with approval from the Illinois State Board of Education, recommends the bid be awarded to Aramark Correctional Services, of Downers Grove, IL, for an approximate annual amount of \$184,800.00. This cost will fluctuate based upon population. This amount is based on an average daily population of forty-two (42) , for three (3) meals and two (2) snacks per day. This contract will begin August 3, 2021 and continue through and including August 2, 2022, with two (2) additional one (1) year optional renewals, if the County so chooses, and

WHEREAS, the Legislative & Judicial Committee concurs with this bid award and recommends approval to the full County Board.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the bid to Aramark Correctional Services, of Downers Grove, IL , for an approximate annual amount of \$184,800.00. This cost will fluctuate based upon population. This amount is based on an average daily population of forty-two (42), for three (3) meals and two (2) snacks per day. This contract will begin August 3, 2021 and continue through and including August 2, 2022, with two (2) additional one (1) year optional renewals, if the County so chooses.





Furthermore, additional documents and/or agreements, including those developed by the contractor, cannot become part of the executed contract.

All procurement transactions must be conducted in compliance with the Conflict of Interest standards and requirements included in 2 CFR 200.112 and 2 CFR 200.318. All procurement transactions must be conducted in a manner providing full and open competition consistent with the standards of 2 CFR 200.319. In order to ensure objective contractor performance and eliminate unfair competitive advantage, contractors that developed or drafted specifications requirements, statements of work, or invitations for bids or requests for proposals must be excluded from competing for this procurement.

Following the contract award, you must submit the enclosed *Post-Contract Award Summary Sheet* along with all requested documentation noted on the form. Ensure also the certification statement is signed by the school food authority's authorized representative.
