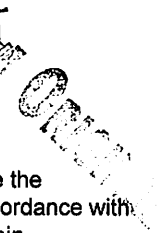
Question # 3: Can you please clarify what you mean by a 10% bid Bond or Cashiers' Check. 10% of what exactly?
