WHEREAS, the Executive's Office Deputy Chief of Staff's recommendation is that the bid for Paratransit Integration and Efficiency Study Consultant be awarded to the lowest responsible bidder of VIA Mobility LLC, New York, NY, for an estimated total cost of \$155,000.00.

WHEREAS, the Executive Committee concurs with this recommendation.


