



**RESOLUTION OF THE COUNTY BOARD

***Awarding Contract to Indicom Electric Company for Electrical Switchgear at the
Will County Morgue/Coroner Building***

WHEREAS, in order to obtain the most competitive rates for the Will County Morgue Building for Bid Package #2, category 2-05 Electrical Switchgear, proposals were solicited, and

WHEREAS on May 25, 2022, the County Executive's Office opened two (2) bids for the Will County Morgue Building for Bid Package #2, category 2-05 Electrical Switchgear, and

WHEREAS, the County Executive's Office and Leopardo Companies have recommended, and the Executive Committee has concurred, that a contract be entered into with the lowest responsible bidder of Indicom Electric Company, LLC, Rockdale, IL for a total cost of \$41,000.00, and

WHEREAS, pursuant to §2.1.6.1 of the contract between Leopardo Companies and the County of Will, the award of a trade contract is assigned by the County of Will to Leopardo Companies and the lowest responsible bidder shall be known as a subcontractor.




Based on approvals below, the above subcontractor will be released to provide all shop drawings, submittals, and material, for performance of the work including, but not limited to:
