Awarding Bid for Morgue Bid Package #3 Category 3-05 Glazing

WHEREAS, in order to obtain the most competitive rates for the Will County Morgue Building for Bid Package #3, category 3-05 Glazing, proposals were solicited, and

WHEREAS on July 21, 2022, the County Executive's Office opened three (3) bids for the Will County Morgue Building for Bid Package #3, category 3-05 Glazing, and

WHEREAS, the County Executive's Office and Leopardo Companies have recommended, and the Executive Committee has concurred, that a contract be entered into with the lowest responsible bidder of Euro Architectural Products, Hoffman Estates, IL for a total cost of \$199,231.00, and

WHEREAS, pursuant to §2.1.6.1 of the contract between Leopardo Companies and the County of Will, the award of a trade contract is assigned by the County of Will to Leopardo Companies and the lowest responsible bidder shall be known as a subcontractor.





Based on approvals below, the above subcontractor will be released to provide all shop drawings, submittals, material, and labor, for performance of the work including, but not limited to:
