Awarding Bid for Morgue Bid Package #3 Category 3-26 Landscaping

WHEREAS, in order to obtain the most competitive rates for the Will County Morgue Building for Bid Package #3, category 3-26 Landscaping, proposals were solicited, and

WHEREAS on July 21, 2022, the County Executive's Office opened two (2) bids for the Will County Morgue Building for Bid Package #3, category 3-26 Landscaping, and

WHEREAS, the County Executive's Office and Leopardo Companies have recommended, and the Executive Committee has concurred, that a contract be entered into with the lowest responsible bidder of Twin Oaks Landscaping, Oswego, IL for a total cost of \$42,340.00, and

WHEREAS, pursuant to §2.1.6.1 of the contract between Leopardo Companies and the County of Will, the award of a trade contract is assigned by the County of Will to Leopardo Companies and the lowest responsible bidder shall be known as a subcontractor.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to award a contract for Bid Package #3, category 3-26 Landscaping, with the lowest responsible bidder of Twin Oaks Landscaping, Oswego, IL for a total cost of \$42,340.00 and said award is assigned to Leopardo Companies by operation of §2.1.6.1 of the contract between Leopardo Companies and the County of Will.





Based on approvals below, the above subcontractor will be released to provide all shop drawings, submittals, material, and labor, for performance of the work including, but not limited to:
